TAX LEVY RESOLUTION

RESOLUTION NO. 2024-18

A RESOLUTION OF THE TOWNSHIP OF FAIRVIEW, County of York, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the Township of Fairview subject to taxation for the fiscal year 2025, as follows:

Tax rate for general purposes, the sum of.....0.00175 mills
on each dollar of assessed valuation, or the sum of..... 17.5 cents
on each one hundred dollars of assessed valuation.

For Fire purposes, the sum of0.00023 mills
on each dollar of assessed valuation, or the sum of..... 2.3 cents
on each one hundred dollars of assessed valuation.

For Street Light purposes, the sum of000000 mills
on each dollar of assessed valuation, or the sum of.....47.0 cents/ 1 ft. Improved
on each one hundred dollars of assessed valuation..... 13.0 cents/1 ft. Unimproved

For Fire Hydrant purposes, whether or not exempt from taxation the sum of 0.000090 mills
on each dollar of assessed valuation, or the sum of.....0.009 cents
on each on hundred dollars of assessed valuation.

The same being summarized in tabular form as follows:

Description	Mills on Each Dollar of Assessed Valuation	Cents on Each One Hundred Dollars of Assessed Valuation
Tax Rate for General Purposes	.00175 Mills	17.5 Cents
Tax Rate for Fire Protection	.00023 Mills	2.30 Cents
Tax Rate For Street Light	0.0	47.0 Cents per 1 foot of Improved Property 13.0 Cents per 1 foot of Unimproved property
Tax Rate for Fire Hydrants	.00009 Mills	0.009 Cents

Further be it resolved that the following taxes are also established as part of the 2025 Budget;

- **Earned Income Tax (EIT):**

As authorized and defined by the General Revenue Tax Chapter 264, Article VI, of the Code of Ordinances of Fairview Township, York County, Pennsylvania, for the purposes of the Earned Income Tax the Township shall collect at a rate of 0.5% on earned income and net profits of individual residents of Fairview Township, and a rate of 1.0% on earned income and net profits of non-residents of Fairview Township derived from any work, business, profession or activity of any kind engaged in within the boundaries of Fairview Township.

- **Local Services Tax (LST):**

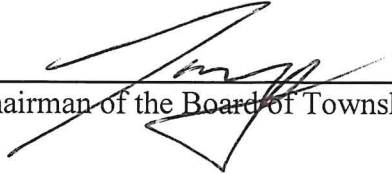
As authorized and defined by Chapter 264, Article IV, of the Code of Ordinances of the Township of Fairview, York County Pennsylvania, for the purposes of providing for Fire, Police and other Emergency Services, and Road Maintenance, the amount of \$52.00 per calendar year with an exemption on the first twelve thousand dollars of income (\$12,000.00).

- **Real Estate Transfer Tax:**

As authorized and defined in Chapter 264, Article III, of the Code of Ordinances of the Township of Fairview, York County Pennsylvania, a tax on the transfer of Real Property at the rate of 1% of the value of the real estate represented by the document involved in the real estate transaction.

AND, that any resolution, or part of any resolution, conflicting with this resolution be and the same is hereby repealed insofar as the same affects this resolution.
