Winter Reminders

Plows travel down the right side of the roadway, the same direction as normal traffic flow. To minimize the amount of snow pushed by a plow into your driveway, place shoveled snow on the right side of the driveway to wait until the plows have completed the street and have pushed the snow back to the curb. Throwing snow back into the street after plowing is illegal and a violation of township ordinance. Portable basketball hoops **MUST** be removed from streets; this is also a violation of township ordinance. Note: Ensure emergency responders can quickly access fire hydrants by clearing snow from around the hydrants nearest your home.

REMINDER TO ALL LANDLORDS

FAIRVIEW TOWNSHIP CHAPTER 224-5 (ORDINANCE 92-4)

Any changes in the use or occupancy of any dwelling unit or business unit owned by such landlord must be reported on forms provided by the Township. Changes shall include the name or names of new tenants of such dwelling unit or business unit, the date when such change was affected and the forwarding address of the old tenant or tenants, if known. YORK COUNTY AGENCY OF AGING RENT-A-KID PROGRAM

This program provides opportunities for middle and high school students, to assist older adults by completing routine light-duty household chores and yard work such as mowing lawns and shoveling snow. The goal of the Rent-A-Kid program is not only to get an important job done, but also to foster friendships between older adults and youth.

Adults age 60 and older in need of assistance with chores can call the Rent-A-Kid coordinator who will provide names and phone numbers for youth in their area. It is the responsibility of the older adult to contact the youth and discuss the job to be done, when it is to be done, the rate of pay for the job, and any other arrangements that need to be made.

Recommended pay rate is at least minimum wage. However, depending on the type of work and the ability of the older adult to pay, the youth may negotiate a more satisfactory rate of pay.

BASIC RESIDENTIAL GUIDELINES

- Trash, Recycling, one bulk item and yard waste (on scheduled dates) must be curbside by 6:00 AM on your scheduled collection day.
- No more than six (6) trash bags or containers will be collected per collection.
- Mobile Carts count as a total of three (3) bags or containers.
- Bags or containers must not exceed 32 gallons or 40 pounds.
- Bulk items that are too heavy to be lifted into a truck by two people will not be accepted.
- Call Penn Waste to schedule collection of appliances containing freon (air conditioners, refrigerators, freezers, etc.)
- No construction debris will be collected curbside.

Please understand that after the plow truck goes through, you will likely have to clear out the end of your driveway again.

Finally, for those that have sidewalks. You are obligated by township ordinance to clear those sidewalks of snow/ice. We ask for your cooperation in making sure that this gets done.

BUILDING, ZONING & CODES

CAN WE FIND YOU?

Who really wants - a cold pizza OR their special limited edition one-of-a-kind autographed rock returned OR to have their loving in-laws getting lost trying to find their home; ALL because they could not find your address!

Unfortunately, finding a property is more of a common problem than most of us think or realize. The lack of visible property addresses can: complicate deliveries; create confusion for unfamiliar visitors; and in emergency situations - be extremely critical for a faster response from emergency personnel.

HUH, WHAT WAS THAT? OF COURSE, FAIRVIEW TOWNSHIP HAS A REGULATION REGARDING THIS! ORDINANCE § 96-5 POSTING OF NUMBERS.

“Numbers as assigned to the buildings in the Township according to the provisions of this chapter shall be affixed to or painted upon or carved upon such building or upon a standard base or support between such building and street. Each number shall be of such height, color and material as to be visible from the street and shall be constantly maintained in complete and legible form. In the case of a building occupied by other than the owner thereof, the occupant, as well as the owner, shall be responsible for maintaining numbers upon such buildings as hereby required.”

As property owners, let's all do our part. The next time you are out grabbing mail, going for a walk, playing in the street, raking leaves or shoveling snow, take a look at your house/property from the street:

- Can you clearly see your address?
- Are there any obstructions blocking the address (tree branches, plants, decorations)?
- Are the assigned street numbers posted at a height so that they are visible in ALL weather conditions?
- Are the numbers fading or do they have enough contrast against the area they are mounted against to be seen?
- If your address is located on a post or on a mailbox at the street - is it large enough and distinguishable enough to be seen?

Addresses can often be overlooked, however a small and relatively quick evaluation by owners can identify any concerns and, in most situations, be easily corrected so no one has to experience someone not being able to find their property.



BEST MANAGEMENT PRACTICES (BMPS) FOR WINTER

- * Use de-icing materials sparingly:
 - Apply the minimum amount of salt needed to be effective. Follow product instructions to avoid over applications. Be aware that salt is often ineffective once temperatures drop below 15°F.

Consider alternative traction materials: Opt for materials like sand, cat litter, or even cracked cornmeal for traction at very low temperatures.

Proper snow piling: When clearing snow, pile it in locations where the meltwater can infiltrate into the ground rather than running directly into storm drains or local waterways. Piling snow in long, low mounds helps with absorption and faster melting times compared to tall, tight piles.

Clear storm drains: Ensure that snow and ice are cleared away from storm drain inlets to allow for proper drainage during thaws and to prevent pollutants from entering the system.

Vehicle maintenance: Ensure municipal and personal vehicles are maintained to prevent leaks of oil and antifreeze, which are common stormwater pollutants.

Sweep up excess salt: or de-icing agents materials after they have worked to prevent them from washing into storm drains. Salt and sand storage: Store de-icing agents under cover to prevent runoff from carrying the material into the stormwater system.



ON-LOT SEPTIC MANAGEMENT

Fairview Township's Act 537 Plan as approved by PA DEP, Chapter 18, Part 6 requires that on-lot septic systems must be pumped at least once every four (4) years. The Township is divided into four (4) septic zones, with zone 3 due for pumping in 2026. To find out what zone you are located in, please visit the Township's website to view the Septic Zone Map.



As a property owner, you are required to:

- Have your system pumped and inspected by a certified pumping hauler.
- Submit the septic system report (manifest report) to the Township within 30 days of the pumping.

You can view the full on-lot septic ordinance online at www.twp.fairview.pa.us.

Again, if your property is within zone 3 and your system has been pumped within four (4) years, please disregard any correspondence you may receive as long as the Township was copied with your pumping manifest. MS4/STORMWATER MANAGEMENT INSPECTIONS DUE BY MARCH 15, 2026

Post construction stormwater management best management practices (PCSM BMP's) inspections are due to Fairview Township by March 15th.

Attn: Homeowners, HOA's and/or business/property owners - if you have a stormwater BMP on your property, you may be responsible for the ongoing inspection and maintenance of that facility. Examples of these include, but are not limited to: Detention/Retention ponds, infiltration ponds, infiltration pits, swales, infiltration berms, stormwater quality inlets, and others. These facilities require proper operation and maintenance to ensure they are functioning properly. Inspection forms are available on the MS-4/Stormwater page of the Fairview Township website. These inspection forms are due by March 15th of each calendar year.
